The Board of Studies Meeting for School of Management Studies was convened digitally on 30.06.2020 (Tuesday) at 11.30 am.

The welcome address was delivered by the Dean, Dr. Bhuvaneswari G. and the members of the Board were introduced. The members were given a comprehensive report on the academic programs of the School and all the academic activities carried out by the department as specified in the academic calendar of the University. The Board was informed about the university's 39th rank in NIRF and 12B Status conferred by the UGC due to its consistent progress in research and development activities.

The resolutions of BOS meeting held on 05/04/2019 were reviewed. The need for the revision of Pedagogy and Assessment Patterns for all the Postgraduate and Undergraduate programs was discussed. After a brief appraisal, the Agenda items listed were taken up for discussion and the following resolutions were passed. The minutes of BOS meeting were approved by the members.

Agenda Note 1:

To approve conducting online arrear examinations for the students pursuing post-graduate and undergraduate programs in the wake of the pandemic COVID19.

The need to conduct online arrear examinations for the students of undergraduate and postgraduate programs was discussed in detail. Considering that all the students registering for arrear exams have already attended classes in person covering the syllabus of the subject for which they will be attending arrear exams, approval has been sought to conduct online examinations to facilitate and reduce anxiety amongst the students. The pattern of digital assessment and the factors such as online security, procedure to compute the marks obtained etc. were discussed.

Agenda Note 2:

To review the mini project and professional training requirements for the Postgraduate and Undergraduate programs.

The requirements for the execution of a Mini-Project by Postgraduate students and also attending Professional Training sessions by Undergraduate students on completion of their 2nd and 5th semester respectively has been discussed in detail. 
